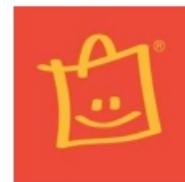


Regulation for the Acquisition of a MAR Shopping Algarve “Chefs Movie Nights - Dinner & Movie Menu” Voucher

1. MAR Shopping Algarve “Chefs Movie Nights - Dinner & Movie Menu” Vouchers in the value of €15 (fifteen euros) (hereafter called “Vouchers”) can be purchased at the MAR Shopping Algarve Information Desk, on Floor 0.
2. Vouchers include the following products/services:
 - (i) ONE DINNER: offer of one dinner within the previous menus announced by each restaurant listed in the Adherent Restaurant List, available on www.marshopping.com (hereafter “Adherent Restaurant”);
 - (ii) ONE MOVIE: offer of one movie at MAR Shopping Algarve NOS Cinema, without prejudice of what states point 3;
 - (iii) MAR Shopping Algarve LEGO® Fan Factory: offer of 3 (three hours) in MAR Shopping Algarve LEGO® Fan Factory, the supervised children’s space in MAR Shopping Algarve. Addition of 1 (one) extra hour of the regular permanence period established for the space, which is 2 (two) hours maximum. (*)
3. The following products/services are explicitly excluded from Vouchers:
 - (i) Upgrade to 3D format cinema;
 - (ii) 3D glasses;
 - (iii) Access to VIP seats;
 - (iv) Access to the cinema room with IMAX technology in MAR Shopping Algarve NOS Cinema.
4. MAR Shopping Algarve LEGO® Fan Factory is open from Monday to Sunday, from 10h00 to 24h00, exception December 24th and 31st, closing at 19h00, and is closed on December 25th and January the 1st. Access is allowed to children between the ages of 3 and 10 and is processed in order of arrival to the space, according to the capacity available at the time of access.
5. Vouchers can only be exchanged in the Adherent Restaurants, whose list can be consulted in www.marshopping.com or at MAR Shopping Algarve Information Desk, on floor 0. The list of Adherent Restaurants published in the site is the most updated and can be changed at any time by IKEA Centres Portugal, S.A., according to the restaurants adhesion at each time.
6. The LEGO® Fan Factory voucher can only be used in MAR Shopping Algarve LEGO® Fan Factory.
7. Vouchers can be used from Monday to Thursday (except on holidays), from 6pm.
8. The Voucher holder can use it only once in one of the products/services described in the above number 2 and should be exchanged in one of the MAR Shopping Algarve Adherent Restaurants, Cinema NOS and LEGO® Fan Factory.



9. Expiration date:

9.1. The Voucher expiration date as way of payment of the products/services above described is shown in the back side of each Voucher. The expiration date will be printed once and must be perfectly readable, with no erasures, as not to raise any doubts. MAR Shopping Algarve, Adherent

Restaurants or Ingka Centres Portugal, S.A. will not accept any erased Voucher, especially regarding the expiration date.

9.2. MAR Shopping Algarve, Adherent Restaurants, NOS Cinema or Ingka Centres Portugal, S.A. are not responsible for exchanging or reimbursing expired Vouchers and the holder has no right of any compensation resultant of the impossibility of using the referred Vouchers.

10. Vouchers cannot be converted into cash. The Voucher holder with more than one Voucher is not required to use them all in one single Adherent Restaurant.

11. If the total value of the dinner is lower than the facial value of the Voucher, neither the Adherent Restaurant nor Ingka Centres Portugal, S.A. will refund, in any way, the respective difference.

12. Vouchers cannot be combined with any other existing promotions in the Adherent Restaurants.

13. MAR Shopping Algarve, Adherent Restaurants, NOS Cinema and Ingka Centres Portugal, S.A. are not responsible for the loss, deterioration, theft or misleading of the Vouchers.

14. Ingka Centres Portugal, S.A. reserves the right to suspend the Voucher sale at any time, however, the expiration date of the already acquired Vouchers will be respected.

15. Vouchers can be acquired with cash or ATM card (immediate withdraw of the Voucher), with a check to "Ingka Centres Portugal, S.A." (Voucher withdrawn upon receipt).

16. Under the law, the following cash payments thresholds apply:

- a. People/companies residing in Portugal cannot pay or receive cash amounts equal or superior to EUR 3.000 (or the equivalent in foreign currencies)
- b. Payments equal or superior to EUR 1.000 (or the equivalent in foreign currencies), made by IRC taxable persons and by individuals that have or should have organized accounting, must be made through a payment method that enables the identification of the recipient, namely by bank transfer, nominative cheque, or direct debit.
- c. The cash payment threshold for individuals residing in Portugal is of EUR 10.000 (or the equivalent in foreign currencies), seeing that these individuals do not act as business people or traders.
- d. For calculation purposes of the referred thresholds, all payments associated with the sales of goods and services are considered, even if they do not exceed the applicable threshold when considered in a fractioned way.

Thus, if the abovementioned thresholds are exceeded, the respective cash payment will not be accepted and in the situation described in b) payments must be made through a payment method that enables the identification of the recipient, namely by bank transfer, nominative cheque, or direct debit.
